Introduction

1. Interactive audience voting has been set up on behalf MultiChoice Nigeria Ltd and MultiChoice South Africa to enable Big Brother Titans viewers to vote for their favourite housemate whom they would like to see win the Big Brother Titans competition. The voting has been set up to encourage viewer participation in the show and give them a say in the outcome of the show.

Competition terms and conditions

- 2.
