

## **Food Trail: South Africa Competition – Additional Rules**

1. The competition will commence on **Monday, 13 April 2026 at 12:00 (midday)** and will close on **Friday, 1 May 2026 at 12:00 (midday)**. No late entries will be accepted.
2. To be eligible for entry, participants must:
  - 2.1. Correctly answer the following question: *“When does Food Network premiere Food Trail: South Africa? Please include both the date and time.”*
  - 2.2. Submit their answer, together with all required personal details, via the official entry link provided on the DStv WhatsApp channel
3. A total of **three (3) winners** will each receive a **signed cookbook by Warren Mendes**.
4. Entries received after the stated closing date and time will be **invalid and will not be considered**.

### **Prize:**

Three (3) winners will each receive a **signed cookbook by Warren Mendes**.

**Winner Selection:** Winners will be selected by means of a random draw.

**Prize Conditions:** The prize is non-transferable, non-exchangeable, and may not be redeemed for cash.

21. We may require you to provide us with such addi)onal informa)on and documenta)on as we may reasonably require processing, confirming and facilita)ng your acceptance and/or use of a prize. If you refuse to provide us with the requested informa)on or documenta)on, you will forfeit the prize.

any ac)on taken by us or any of our affiliates in accordance with the terms and condi)ons.

In the event of your death, your family, dependents, heirs, assignees or any other beneficiaries of your estate, indemnify and hold us and our affiliates harmless against any claim by you, or your partner (if applicable), (whether direct, indirect, incidental, puni)ve or consequen)al) of any nature, whether arising from negligence or any other cause, rela)ng to any injury, loss, liability, expense and/or damage which you may suffer, howsoever arising, in rela)on to your entry into this compe))on and/or acceptance and/or use by you of a prize.

You acknowledge that the acceptance and use of a prize is subject to the proviso that all of the terms and condi)ons will apply to both you and your partner (if applicable), and you will ensure that your partner agrees to be bound and complies, and will con)ue to comply, therewith; you will take full responsibility for your partner; you indemnify and hold us and our affiliates harmless against any claim by your partner or any third party in the event that your partner suffers any loss or damage pursuant to your partner's acceptance and/or use of a prize.

29. Any minor will be accompanied by a parent or legal guardian.

33. You indemnify and hold us and our affiliates harmless against any claim by any person, (whether direct, indirect, incidental, puni)ve or consequen)al) of any nature, whether arising from negligence or any other cause, rela)ng to any death, injury, loss and/or damage which

may be suffered howsoever arising in relation to your failure (or that of your partner, if applicable) to comply therewith.

34. For purposes hereof, "affiliate" means our partners, co-promoters, agencies and sponsors of this competition, our subsidiaries, our and their subsidiaries and respective holding companies, the subsidiaries of their holding companies, and our and their directors, officers, employees, agents, and representatives.

35. These terms and conditions will be construed, interpreted and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.

36. MulChoice and the judges' decision on any matter concerning the competition and/or arising out of these terms and conditions is final and binding on you, and no correspondence will be entered in to.

37. The judges' decision is final, and no further correspondence will be entered.

38. The prize is not negotiable, not transferrable and cannot be exchanged for cash.

39. If a winner chosen does not comply, their entry will be disqualified, and a new winner will be selected based on their online entry.
